Discussion covered a By-Law amendment, our cost-share for delivery from July 2019 through June 2020, and election of LLNJ Board members. MAIN Deliver Task force continues to formulate a plan should state-wide delivery be disbanded.

- MAIN is working on a fix for illegal downloading from member libraries' public WiFi.

- NJLA presented a program on making library buildings safer. One of the topics was about Wireless Panic Buttons. Ms. Koch has contacted our fire alarm provider, Denville Police Chief Perna and the Town about types of alarm systems and possible cost-sharing. Ms. Koch will check for Federal Grant money for this, as there have been grants for alarms in schools.
- Ms. Koch has checked with Chief Perna about updating library staff on emergency training.
- Ms. Koch and Ms. Puppo will meet with the Town Purchasing Officer regarding contracts.
- Save the date. MAIN will host a Friend-Raising seminar for Trustees, Friends and Foundations on October 2, 2019 at the Florham Park Public Library. The recent MAIN seminar on legal issues for libraries, attended by Ms. Koch and Mr. Johnson, was well done and useful.
